In compliance with the HALIFAX TOWN CODE Chapter 18 Division I, "it shall be unlawful for any person to keep livestock stabled or penned in the town without a permit from the town to do so..." Furthermore, an issued permit may be suspended due to any violations of conditions or restrictions or due to the following:  Offensive odor;  Unsanitary;  Noise;  Detrimental to the health of the people in the neighborhood or in the town;  Detrimental to the health of the animal or the neighboring animals;  A public nuisance."

The Town of Halifax does not guarantee a livestock permit can be granted on non-agriculturally zoned land. It is dependent on many different factors and an evaluation by the Zoning Administrator of the property and proposed improvements. The undersigned applicant(s) and permittee(s) for the aforesaid livestock permit hereby agree(s) to indemnify and hold the Town of Halifax, Virginia, its officers, agents, and employees, harmless against any claims, losses, damages, attorney fees, or other expenses of any kind arising out of or relating to its operations. Applicant(s) understand(s) to comply with permit restrictions and conditions in addition to the Halifax County Health Department regulations for keeping livestock in the Town of Halifax and that the issuance of this permit in no way releases the applicant(s) from the obligation to obtain any other permits or licenses, and zoning requirements under local, state, federal, or other regulatory agency. In addition, applicant(s) certify(ies) that this application and the foregoing answers, statements and other information submitted are all in respects true and correct to the best of their knowledge and belief.
